## **Special Board Meeting Minutes** (file 170309)

March 9, 2017 – Ouray County Land Use office, Ridgway, Colorado (Note: Items recorded in accordance with adopted agenda notwithstanding sequence of discussion)

<u>Present</u>: Board members Michael Boland, Joey Huddleston, Vonnie Kuijvenhoven, Coleen McElroy and Richard Wojciechowski and administrator Karla Cline.

- 1. Call to Order at 1732 by Michael Boland.
- 2. Introduction of new administrator: The board welcomed Karla Cline as the new RSA administrator.

All board members signed the request after personally reviewing it, and also signed a file copy. Richard will mail the request certified mail, receipt requested, per the auditor's recommendation.
- 5. Sprinkler/Rainmaker contract: Mike reported he sent the letter demonstrating that RSA had paid the Rainmaker invoice and also canceling the automatic renewal. Board discussed potential alternate vendors to service the sprinkler system.

## 6. Other:

- a. **Transparency notice**. Richard had been unable to find a current transparency notice on DropBox, but the county did have it on file. Richard generated an amended notice that updates the name of the administrator and notes that special meetings, when required, are held on the dates of the workshops. Board decided a formal action is appropriate. **MOTION** by Richard, second by Coleen to amend the transparency notice. Motion passed. Richard will post to web site and send to DoLA and county.
