### 3. Approval of September 16, 2025 RSA Board Meeting Minutes

a. Motion to approve the September 16, 2025 Board Meeting Minutes without changes. Motion by Mary Ann, 2<sup>nd</sup> by Laura, all in favor, motion passed.

#### 4. Public Input

- d. COVID vaccines given at OC Public Health or in Montrose at pharmacies.
- e. MA Update: Losing 2 of 3 in the next month (transferring back to Montrose). Really need help retaining staff.
- f. Electrician Update for security lights: should be done soon.

  - i. Potential issue regarding using public funds for a for-profit company. Treading carefully and seeking legal advice to ensure proper use of our public funds.
  - ii. Devin recommends we review Senate Bill 19-052 concerning expansion of an emergency medical service provider's scope of practice.
    - 1. Could hiring EMTs help with MA shortage?
  - iii. Need to hear back from the Special District lawyer in Denver about what RSA can actually do with the public funds.
    - 1. Could also reach out to a lawyer through the SDA since we are members there.
- c. Presentation of Preliminary Budget for 2026
  - i. Presentation by Josey & board discussion regarding the budget. No major changes requested from the draft changes made last month.
  - ii. Josey to upload the preliminary budget to the RSA website for community review.

    - 2. Amendment: Include Ouray County Public Health (OCPH) at the top of the form, bottom of the form, under II. Parties, and throughout the document as appropriate. Change verbiage to "all" instead of "both."
      - Under V. Roles & Responsibilities Add C. OCPH & roles as appropriate, including in-kind donations.
